

2023 SUMMARY ANNUAL REPORT

For Virginia Bankers Association Group Medical and Dental Trust

This is a summary of the annual report of the Virginia Bankers Association Group Medical and Dental Trust, EIN 54-1741662, Plan No. 501, for the period January 1, 2023 through December 31, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with Anthem Health Plans of Virginia (dba Anthem BCBS, GI605), Inc. to pay vision, EAP and stop loss claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2023 were \$5,251,100.

Additional Plan Information

The plan has also committed itself to pay certain self-funded health, dental and prescription drug claims incurred under the terms of the plan, administered by Anthem Health Plans of Virginia, RxBenefits/Express Scripts and Delta Dental.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$24,655,743 as of December 31, 2023, compared to \$17,455,471 as of January 1, 2023. During the plan year the plan experienced an increase in its net assets of \$7,200,272. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$87,267,270 including employer contributions of \$85,327,939, and earnings from investments of \$1,939,331.

Plan expenses were \$80,066,998. These expenses included \$80,377,406 in benefits paid for participants and beneficiaries. Please note that these figures reflect all lines of coverage that may not be applicable to your benefit offerings.
