

2023 SUMMARY ANNUAL REPORT

For State Bankers Association Group Insurance Trust

This is a summary of the annual report of the State Bankers Association Group Insurance Trust, EIN 54-1741662, Plan No. 502, for the period January 1, 2023 through December 31, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with Minnesota Life Insurance Company, Vision Service Plan, UNUM Life Insurance Company of America, Lincoln National Life Insurance Company and Hartford Life & Accident/Express Scripts to provide insurance for Life Insurance, AD&D, Vision, Group Long Term Care, Short-term Disability, Long-term Disability and Retiree Medicare Supplement coverages under the plan terms. The total premiums paid for the plan year ending December 31, 2023 were \$6,487,288.

Of the total insurance premiums paid for the plan year ending December 31, 2023, premiums paid under an experience-rated contract were \$813,899. The total of all benefit claims paid under these contracts during the plan year was \$708,003.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$40,350 as of December 31, 2023, compared to \$38,429 as of January 1, 2023. During the plan year the plan experienced an increase in its net assets of \$1,921. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$7,363,520.

Plan expenses were \$7,361,765. These expenses included \$7,361,765 in benefits paid for participants and beneficiaries. Note these figures reflect all lines of coverage that may not be applicable to your benefit offerings.
